Patient Consent and Authorization

AGREEMENT TO PAY:

I agree to be personally responsible for the payment of all services rendered on my behalf, if the person listed on my information sheet, as being responsible, fails for any reason to do so.

In the event a quotation of fees is not given to me before the services are performed, I shall ask for such quotation or waive my right to later claim the fee exceeded the value of services rendered.

I understand that if credit is extended, it is done so on the basis of the financial information herein or otherwise obtained from me.

Unless other arrangements are made with this office, payment for dental services is expected at the time of service. Interest at 18% per annum, plus a service charge, may be added to any past due balance.

If collection services or legal services are required to obtain payment of the amount owed, I further agree to pay for all legal fees and costs reasonably incurred in connection therewith.

Interest not paid when due, shall be added to and become part of the principal.

APPOINTMENTS:

We value your time and do our best to stay on schedule. Please be here at your scheduled appointment time. If you arrive more than 10 minutes after your scheduled time, you may need to be re-appointed. Once an appointment is made, please remember this time has been reserved for you. A minimum charge will be made for failed or canceled appointments, without prior notification of 24 hours.

INSURANCE:

To avoid misunderstanding regarding dental insurance, we wish our patients to know that all professional services rendered are charged directly to the patient and that patients are personally responsible for payment of fees **not** paid by insurance. We will prepare necessary forms to help you obtain your benefits from insurance companies. **Payment of your deductible and any copayment is due at the time of service.** We do not render our services on the basis that insurance companies will pay all our fees. Each fee and co-pay is unique to the patient's particular insurance plan. This office uses a white composite material for our fillings. Some insurance companies are still only paying for silver mercury fillings in the back teeth. There may be a small difference in this benefit which the patient will have to pay. The same will apply to porcelain crowns. If you have any questions please ask the front office staff.

HIPAA NOTICE OF PRIVACY PRACTICES

THIS NOTICE DESCRIBES HOW MEDICAL INFORMATION ABOUT YOU MAY BE USED AND DISCLOSED AND HOW YOU CAN GET ACCESS TO THIS INFORMATION. PLEASE REVIEW IT CAREFULLY.

Your protected health information (i.e., individually identifiable information, such as names, dates, phone/fax numbers, email addresses, home addresses, social security numbers, and demographic data) may be used or disclosed by us in one or more of the following respects:

- To other health care providers (i.e., dental specialist such as oral surgeon, endodontic, etc.) in connection with our rendering dental treatment to you (i.e., to determine the outcome of extractions or root canals, etc.);
- To third party payors or spouses (i.e., insurance companies, employers with direct reimbursement, administrators of flexible spending accounts, etc.) in order to obtain payment of your account (i.e., to determine benefits, dates of payment etc.)
- To certifying, licensing and accrediting bodies (i.e., The American Dental Association, state dental boards, etc.) in connection with obtaining certification, licensure or accreditation;
- Internally, to all staff members who have any role in your treatment;
- To other patients and third parties who may see or overhear incidental disclosures about your treatment, scheduling, etc.;
- To your family and close friends involved in your treatment; and/or,
- We may contact you to provide appointment reminders or information about treatment alternatives or other health-related benefits and services that may be of interest to you.

Any other uses or disclosures of you protected health information will be made only after obtaining your written authorization, which you have the right to revoke.

Under new privacy rules, you have the right to:

- Request restrictions on the use and disclosure of your protected health information;
- Request confidential communication of your protected health information;
- Inspect and obtain copies of your protected health information through asking us;
- Amend or modify your protected health information in certain circumstances;

- Receive an accounting of certain disclosures made by us of your protected health information; and
- You may, without risk or retaliation, file a complaint as to any violation by us of your privacy rights with us (by submitting inquires to our Privacy Contact Person at our address) or the United States Secretary of Health and Human Services (which must be filed within 180 days of violation.)

We have the following duties under the privacy rules:

- By law, to maintain the privacy of protected health information and to provide you with this notice setting forth our legal duties and privacy practices with respect to such information;
- To abide by the terms of our HIPAA Notice of Privacy Practices that is currently in effect;
- To advise you of our right to change the terms of this HIPAA Notice of Privacy Practices and to make the new notice provisions effective for all protected health information maintained by us and that if we do so, we will provide you with a copy of the revised HIPAA Notice of Privacy Practices.

Please note that we are not obligated to;

- Honor any request by you to restrict the use or disclosure of your protected health information;
- Amend your protected health information if, for example, it is accurate and complete; or
- Provide an atmosphere that is totally free of the possibility that your protected health information may be incidentally overheard by other patients or third parties.
